ELIGIBILITY

Artists, aged 15 and older, who reside in Coshocton, Guernsey, Morgan, or Muskingum counties are eligible to enter the MVHC Annual Juried Competition. Only original 2D work will be accepted. Each artist may submit two entries and all entries must be presented in a professional manner. Accepted work must be exhibition-ready to be included in the show. Framed pieces must be securely wired; glazed plexiglass is preferred; size is restricted to 72 inches in any direction, including the frame.

ENTRY FORM

ENTRY REQUIREMENTS

- Artist may provide up to two separate entries by submitting JPEG images for each work to Amy Kettner, Patient Experience Manager, 716 Adair Ave, Zanesville, OH 43701 or akettner@mvhealthcenters.org
- Entry titles must be labeled as such:
 - First Initial-Last Name-Entry Number
 - For example: An entry by Kelly Smith is labeled as ***K-Smith-1***. If a second view of the work is included, it should be labeled as ***K-Smith-1a***.

METHOD OF SELECTION

The jurors of the annual Juried Exhibition review all images of works submitted. Selected artist will be notified and their works are to be delivered to MVHC.

ACCEPTED ENTRIES

All accepted work must be labeled on the back with the artist's name, title of the work, and price. All works selected for exhibition must be delivered to MVHC, 716 Adair Ave, Zanesville, OH by Friday, August 11 at 5 PM.
